The decisions of the Extraordinary General Meeting of HELMEPA Members that was held on 17 December 2020, marked the strengthening of the links between HELMEPA and the Greek shipping community, as well as the expansion of communication channels in order to project the Association's environmental messages to a wider audience.

In this context, a new membership fee policy was approved by vast majority, with managing companies now registering as Full Members with their entire fleet at a significantly lower fee per vessel, which further decreases depending on the size of the fleet.

The General Assembly also approved unanimously amendments to the current Articles of Association, bringing it in line with contemporary needs. Secretaries of the General Assembly were Messrs. C. Kanellopoulos of Nereus Shipping SA and C. Terzis of Queensway Navigation Co. Ltd.

| MARITIME SECTOR

The Training Program continues with record participation

The seminars of the Refresher Training Program taking place at HELMEPA's Maritime Training Center were suspended in early March 2020 to prevent the spread of the COVID-19 pandemic. Until then, only 4 seminars with 60 participants had been held and the only feasible choice was to continue HELMEPA's Refresher Training Program through **distance learning**, adapting the seminars to webinars. At the time, just before the first lockdown, we could hardly imagine that this full of uncertainty year would end on a positive note in terms of our training activities.

The start was made in mid-April with a comprehensive three-hour version of the two-day "Marine Environmental Awareness" seminar that HELMEPA has been providing to its Members for many years. Eight months later, the webinar on "Ship Handling in Rough Seas", based on theory from HELMEPA's Bridge Simulator training, completed a series of 16 webinars ranging from one to three days. These were attended by **1,000 seafarers** and office staff of Member companies, all of whom received a Certificate of Attendance.

At the same time, HELMEPA decided to grant seafarers and Member companies **unrestricted free access** to the two **e-Learning**

packages it has developed since 2014 in collaboration with DYNAMARINE (i.e., safety related and environmental training courses), which were **successfully completed by more than 550 people**. The **positive comments** and evaluation we received from the participants were remarkable.

The high degree of interaction between participants and lecturers was further enhanced by poll questions, which recorded interesting views on a variety of issues of contemporary shipping.

An important milestone last year was also the **opening of our Training Program to non-Greek-speaking officers of Member companies**, by carrying out webinars also in English. The extensive participation of foreign crews in the English webinars led us to the decision to establish them as a working language in a large part of the offered 2021 Program.

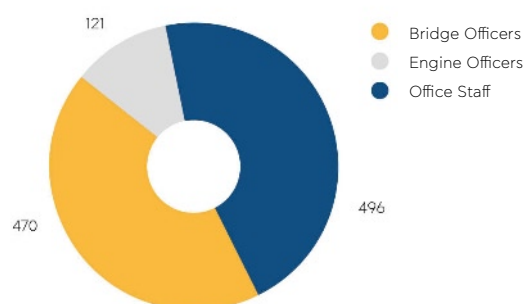

3. Avoiding Pitfalls during PSC Inspections
4. Marine Environmental Awareness
5. Emergency Preparedness and Response
6. TMSA Implementation and Preparation for Vetting Inspections
7. Safe Carriage of Dangerous Solid Bulk Cargoes
8. Ship Handling in Rough Seas (exceptionally, due to suspension of training in the Bridge Simulator)

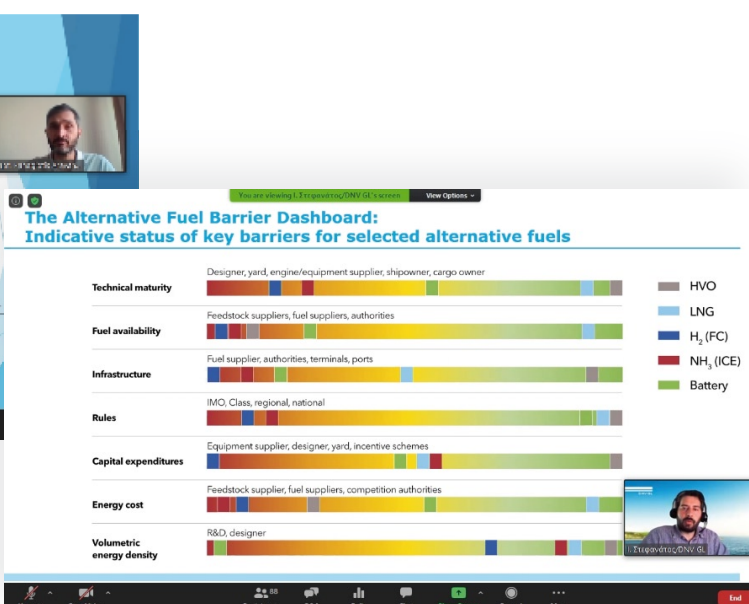
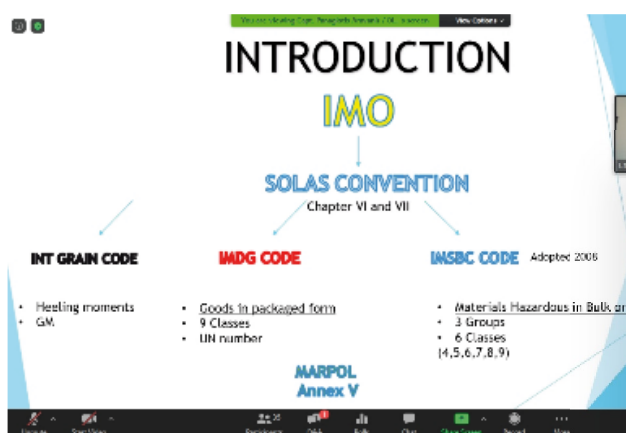
Record participation!

Participation at the 2020 Training Program



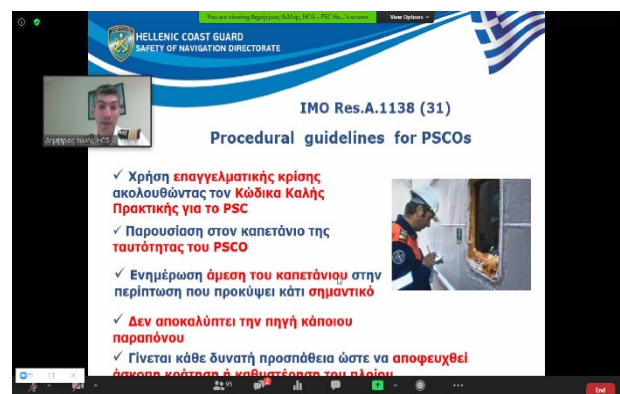
8 out of 10 participants considered the seminars as **highly useful** for performing their duties on-board or in the office.

The Full Mission Bridge Simulator is a kind donation of Associate Corporate Member DNV in appreciation of the Voluntary Refresher Training HELMEPA has been offering to its Members since 1982.



Bridge Simulator Courses

Due to the State prohibition of schools of all types due to the pandemic, only 56 officers (36 Merchant Marine & 20 Hellenic Navy Officers) attended 15 simulation seminars during 52 days in the following 4 categories. In addition, 2 Member companies assessed 6 of their Second Officers and another 6 non-Member company staff attended a 3-day tailor made seminar. All participants received a HELMEPA Certificate of Attendance.

HS1 Bridge Resource Management: a 5-day seminar, consisting of 19 topics delivered during 40 hours (20 hours classroom presentations and 20 hours simulator practice/exercises). It was conducted 7 times with a total of 43 participants. Upon successful course completion, the trainees obtain the official Cyprus Flag BRM Certificate.

HS2 Advanced Ship Handling & Navigational Safety: a 3-day seminar, with 7 hours of classroom presentations and 14 hours simulator practice. It took place 2 times and was attended by 5 participants.

HS3 Navigating in Dense Traffic - Fishing Areas - COLREGs and Loss Prevention: a 2-day seminar consisting of 6 hours classroom presentations and 8 hours simulator practice. It was conducted 4 times and was attended by 5 participants.

HS4 Real Incident Simulation and Root Cause Analysis: a 2-day seminar presenting, simulating and analyzing real maritime incidents obtained from sources, such as MAIB, CHIRP, MARS etc. It was carried out 4 times and was attended by 8 participants.

HELMEPA's Maritime Training Center for Pollution Prevention, Safety at Sea and Environmental Awareness held a reception at the Athens Marriott Hotel (30.01.2020) to honour the lecturers of the annual Training Program, as an indication of sincere appreciation for **their significant voluntary contribution**.

Annual Meeting of HELMEPA Member companies with the US Coast Guard



Due to the pandemic, instead of the established annual meeting between HELMEPA Member operators and the leadership of the US Coast Guard in Washington DC, a web-meeting took place (October) between **Rear Admiral Richard Timme**, Assistant Commandant for Prevention Policy, US Coast Guard, and representatives of 12 Member companies, as well as the Hellenic Coast Guard.

The Admiral's speech titled "**COVID-19 in the Maritime Environment**" covered all relevant contemporary challenges, such as distant inspections and new technologies, Cyber Security and the problems of crew change and repatriation. Reference was also made to the risks and impacts of COVID-19 worldwide and in the USA, whilst the Admiral also mentioned issues regarding vessel's autonomous systems, new fuels and batteries, as well as the meetings of the IMO, which now take place online.

The Chairperson of HELMEPA Ms Semiramis Paliou thanked the Admiral for his time and for the acknowledgment and significance he placed on the issue of crew repatriation.

The Norwegian Ambassador visits HELMEPA



In February, the Ambassador of Norway to Athens Mr. Fr. Ov. Andersen, accompanied by Mmes L. Lothe, Deputy Head of Mission and M. Fola, EEA Grants Advisor of the Embassy, paid a visit to our offices.

During the discussion, possibilities of cooperation between HELMEPA and similar organizations in Norway were examined, with particular emphasis on the younger generations, as well as with the Norwegian Embassy in Athens itself. The visit concluded with a common agreement to continue the discussions, exploring further ideas.

Journalists “navigate” a tanker ship at HELMEPA’s Simulator



Representatives of shipping media had the opportunity virtually pilot a super tanker in the Straits of Bosphorus, as Captains at the Bridge Simulator (February). They witnessed realistic scenarios of navigating and maneuvering a ship in calm as well as dangerous situations, which is what HELMEPA’s simulator offers to Member companies for the training of their officers.

State of the art electronic navigational aids such as GPS, AIS, Echo-Sounder, Speed Log, VDR, RADAR, GMDSS, VHF, Ship Control και Conning Display, ECDIS and the required external and internal communication systems comprise the **certified by DNV** high quality bridge simulator of HELMEPA for several types of vessels.

2,133 HELMEPA Junior activities

despite school closures



The HELMEPA Junior (HJ) Program, operating since 1993, has reached a total participation of **118,872** schoolchildren and **7,323** volunteer teachers from **1,534** Elementary Schools and Kindergartens throughout the country.

In 2020, 463 volunteer teachers participated in the HJ Program, along with their 7,580 pupils who created 824 groups in 227 Elementary Schools and Kindergartens.

Despite school closures since the outbreak of the COVID-19 pandemic in early spring, HJ groups carried out a total of 2,133 activities, most popular of which were recycling, giving relevant information to the local community, learning about physical processes (water cycle, sea currents), shipping and biodiversity.

Many activities were implemented through means of distance learning, with the environmental messages reaching beyond the children and their families. All participants received commemorative diplomas.

News, environmental topics and games which help raise environmental awareness among youth, were communicated to the children through the quarterly newspaper "The Young Seagulls". In fact, **the 100th issue of the children's newspaper, which was first released in 1995**, was published in September!

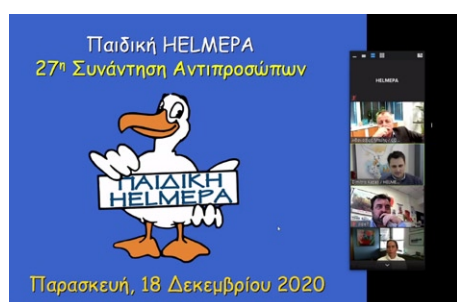

27th Meeting of "HELMEPA Junior" Representatives



Children and volunteer teachers of the most active groups in each region of the country, conveyed their messages for the protection of the environment and were awarded for their activities at the 27th Meeting of Representatives, which took place (December) online, due to the pandemic.

HELMEPA's Chairperson Ms Semiramis Paliou thanked the participants for protecting the environment, while the **General Manager of Costamare Shipping and Member of HELMEPA's Board Mr. Athanasios Beis**, greeted the guests on behalf of the family of the **late Captain Vassilis Constantakopoulos**.

ENVIRONMENTAL EXHIBITIONS

The permanent environmental exhibitions hosted at Member companies Ceres and Costamare operated only during January and February due to the pandemic.

During these two months, we transported and provided guided tours to 611 students and 47 accompanying teachers from 15 public schools in Attica as well as 78 students and 7 teachers from private schools.

From the questionnaires completed by the students, it appears that the information presented was new to 57% of the children, while all children and teachers would recommend to others to visit the Exhibitions.



HELMEPA's mobile exhibition was hosted at the "Angelos Sikelianos" Municipal Theater (24-28 February) under the auspices of the Municipality of Xylokastro, in cooperation with the Association for the Protection of Natural and Cultural Environment of the Corinthian-Patras Gulf "Nireas" and the Primary Education Directorate of Corinth.



During this week, HELMEPA transported and provided guided tours to 500 students and 50 teachers from 8 Primary Schools of Xylokastro, Derveni and adjacent mountain villages, while another 450 High School students from the local area had the opportunity to be introduced to the themes of the exhibition during a special event organized by local stakeholders to raise awareness about the protection of the Corinthian Gulf.

New young members of “HELMEPA Cadets”

The young volunteers aged 13-29 from all over the county, who applied and became HELMEPA Cadets numbered 2,140. Through a dedicated website and the monthly e-bulletin “HELMEPA Cadets’ Periscope”, we inform the Cadets on issues pertaining to the marine environment, scientific research and new technologies and we coordinate their voluntary participation in HELMEPA’s activities.

World Environment Day was chosen for the launching of HELMEPA’s summer campaign for “Clean Seas and Beaches”. Once again the star of this campaign was the Association’s widely popular “Seagull”, reminding us that our return to the beaches must be done with CAUTION and RESPECT to the marine and coastal environment of Greece.

HELMEPA celebrated 30 years of coordination of the International Coastal Cleanup campaign in Greece

Despite the inherent difficulties due to the Covid-19 pandemic, 2,318 volunteers organized and participated in 82 coastal and underwater cleanups throughout Greece, from Alexandroupolis in the north and Kastos island in the Ionian Sea, to the islands of Folegandros in the Aegean Sea and Crete.



Under the motto “We safely conduct beach cleanups” and in compliance with the State’s health and hygiene protocols, children and teachers of 35 Kindergartens, Primary Schools, High Schools and various educational institutions, officers of 5 Port Authorities, members of environmental organizations, as well as other citizens, cleaned 83 km of the coastline, collecting 21 tons of marine litter sending a message of active engagement and collective effort to protect the marine environment.

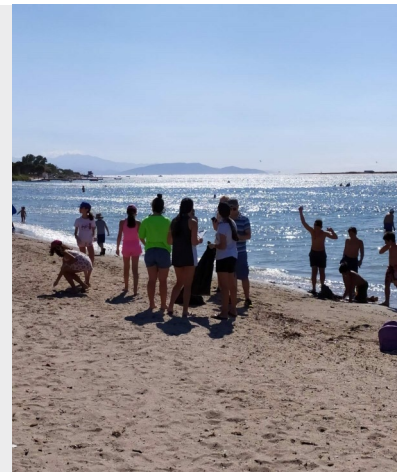

| SYNERGIES

Enhancing the Understanding of New and Enduring Challenges in Maritime Safety in the Eastern Mediterranean

The 3-year program implemented by HELMEPA in collaboration with Associate Members LR, DYNAMARINE and CYMEPA in Cyprus with then kind support of Lloyd's Register Foundation (LRF), was successfully continued during 2020, despite difficulties posed by the pandemic.

The purpose of the program is **to protect human life at sea and reduce maritime incidents and accidents** by promoting the enhancement of maritime safety culture between seafarers and the shipping industry, fishing, yachting, sea tourism sectors, offshore sailing and others.

It comprises, among other, the set-up and operation of a Voluntary Incident Reporting Platform for HELMEPA and CYMEPA members, refresher training seminars for seafarers and shipping companies' staff in Greece and Cyprus, simulation seminars based on the reconstruction of real incidents at HELMEPA's Full Mission Bridge Simulator, safety-at-sea workshops for crews of fishing vessels, mega yachts and recreational craft, e-learning modules and a wide safety awareness campaign in coastal areas of both countries.

VIRP - Voluntary Incident Reporting Platform, an online tool for voluntary reporting of maritime incidents and **"near misses"**.

The platform was constructed by DYNAMARINE with the assistance of HELMEPA's Training Committee and already includes **anonymous data on over 800 incident reports from 45 Member companies that have registered.**

Next steps:

Optimal processing, dissemination and communication of 'lessons learned' to the maritime community and the opening of the online VIRP platform for the reporting of incidents of smaller vessels, such as fishing boats, yachts and sailboats.

The following training initiatives were carried out:

5 seminars & webinars on “Safety First” and “Ship Handling in Rough Seas”

attended by 254 Merchant Marine Officers and office staff of 40 shipping companies in Greece and Cyprus.

15 two-day & three-day simulation seminars with the participation of 50 Deck and Coast Guard

Officers at HELMEPA’s Maritime Training Center.

2 Safety at Sea webinars

attended by 213 fishing professionals, sailors, captains and crews of yachts and recreational boats, marina staff and other sea lovers from many areas of Greece and Cyprus.

The webinars were organized in collaboration with the first professional fishing academy of Greece ENALEIA and the Hellenic Offshore Racing Club with the valuable contribution of the Hellenic Bureau for Marine Casualties Investigation (ELYDNA) and other specialized bodies and professionals.

Particularly encouraging was the high evaluation of seminars/webinars by the participants, who received a HELMEPA Certificate of Attendance.



Safety Ambassadors: 75 individuals and companies/organizations assumed the role of Safety Ambassador of the program in their local communities.

Memorandums of Cooperation for joint environmental action

With the Region of the Ionian Islands

The Governor of the Ionian Islands Region Mrs Rodi Kratsa-Tsagaropoulou visited our premises and discussed with the then Chairman of HELMEPA, Mr George Gratsos, about the potential participation of the region's educational community and local organizations in HELMEPA's environmental programs. This was followed by online presentations of the "HELMEPA Junior" program to teachers on the islands of Zakynthos, Corfu, Kefalonia and Lefkada.



With the Hellenic Navy Seals Association

HELMEPA and the Hellenic Navy Seals Association signed a Memorandum of Cooperation with the purpose of jointly contributing to informing students and seafarers about the environment and safety. In particular, HELMEPA's initiatives, which include voluntary beach cleanups, will be enriched by HNSA divers to highlight the role of humans in marine and seabed pollution. HNSA will also participate with special presentations on safety at sea, in HELMEPA's programs supported by Lloyd's Register Foundation.



Meeting with the Minister of Education



The Minister of Education and Religious Affairs, Ms Niki Kerameos, was visited by HELMEPA's Chairperson Ms Semiramis Paliou, accompanied by Board Member Ms Ioanna Martinou and Executive Coordinator Ms Christiana Prekezes, and discussed ways to strengthen experiential education, the cultivation of environmental skills, environmental awareness and education on climate change. During this highly constructive meeting, both sides agreed to form a framework of cooperation in order to lay the foundations for a stable partnership to promote common goals for the benefit of the educational community and the younger generation. Following the visit and in collaboration with the Educational Policy Institute, we submitted 3 programs in the pilot project "Skills Workshop" aiming to cultivate soft skills among students: "My plastic footprint – Learning, acting, changing", "Voluntary Beach Cleanup" and "HELMEPA Junior – Our friend, the sea".

HELMEPA at Salamis, supporter of 57th Aegean Rally



On Sunday 5 July, HELMEPA staff visited the **Vourkari Nautical Club** in Salamis to inform young sailors and their families about the marine environment, what it offers to us and the dangers it faces. The occasion of this visit was the start of the 57th Aegean Rally, which was supported by HELMEPA, to honor one of the most important battles in human history, the naval battle of Salamis, 2,500 years ago.



LET'S PUT AN END TO SINGLE-USE PLASTICS

The event "Going single-use plastic free: The next step to sustainable growth" was organized by the American College of Greece in collaboration with the A.C. Laskaridis Charitable Foundation

(February 4, Deree), with the **Minister of Environment and Energy, Mr. Kostis Hatzidakis**, as a speaker. The event focused on strengthening the dialogue on single-use plastics and highlighting their impact on the environment, as well as drafting the next steps for a sustainable future and presenting the National Plan of Greece. HELMEPA participated with Executive Coordinator, Ms. Cristiana Prekezes, who referred to the dimensions of the problem and presented data from the voluntary cleanups in Greece.

Visit of officials of the Embassy of Sweden to HELMEPA

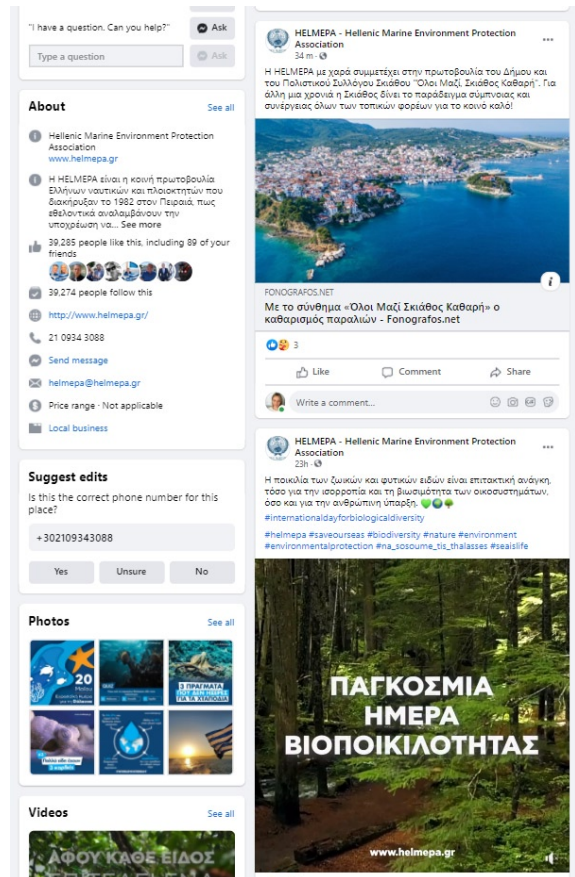
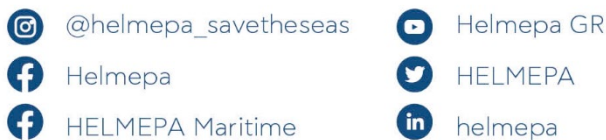

New Membership Fee Policy

Aiming to strengthen HELMEPA's links with the Greek shipping community and expand its communication channels, the newly elected Board of Directors introduced a new membership fee policy, in which **MANAGING SHIPPING COMPANIES** are registered as Full Members with their entire fleets, at a significantly lower fee/vessel, that further decreases depending on the size of the fleet. The new policy is valid from 1/1/2021.

In addition, two categories of Member-Companies were formed:

- **ASSOCIATE CORPORATE MEMBERS** which include, among other, Banks, Classification Societies, P&I Clubs and Registries.
- **CORPORATE SUPPORTERS**, which include shipping suppliers, law firms, insurance companies and brokers, international organizations, environmental and tourism enterprises, marinas and other companies of the maritime cluster, which at a symbolic cost can now contribute as Members to this joint effort.

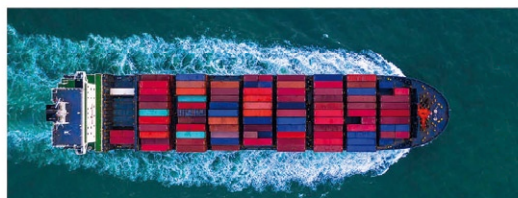

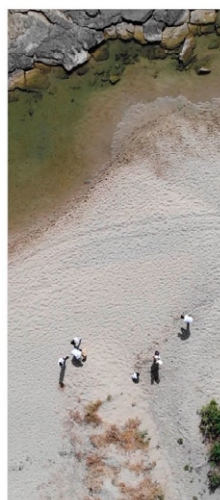
