LARGEST TRAINING IMPACT TO DATE

As part of its ongoing commitment to supporting its members, HELMEPA Academy successfully delivered the 2024 Refresher Training Program, achieving highly positive outcomes.

Throughout the year, 3,232 seafarers and shore-based personnel from 191 companies participated in 37 webinars and seminars, totaling 208 hours of training, with contributions from 67 expert speakers. The program's impact was reflected in participant feedback, with 90% rating the sessions as "Very Good" or "Exceptional", confirming the quality, relevance, and practical value of the content provided.

The program emphasizes holistic skills development, experience-based learning, and inclusive participation, contributing meaningfully to the professional growth, preparedness, and resilience of the maritime and wider community.

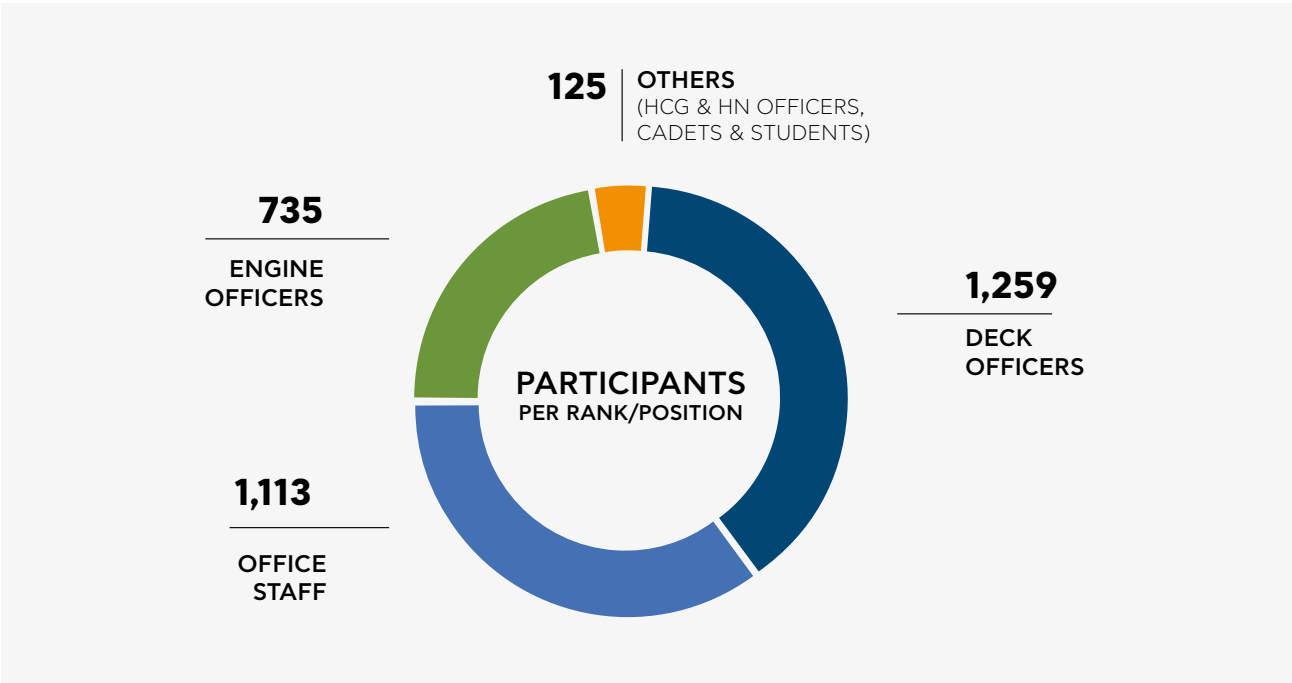

NAUTIS 3 BRIDGE SIMULATOR FOR REALISTIC TRAINING AND ASSESSMENTS

In 2024, HELMEPA's NAUTIS 3 bridge simulator provided highly realistic training to 186 deck officers and 75 cadets and students of Merchant Marine Academies, Nautical Schools and Universities.

The upgraded NAUTIS 3 simulator also enables detailed performance assessments, allowing companies to evaluate and prepare their officers for promotions and leadership roles. All participants received HELMEPA Certificates of Attendance.



HELMEPA's NAUTIS Full Mission Bridge Simulator, manufactured by VSTEP, operates since 2016 in the Association's Maritime Training Centre, following kind donation by member-company DNV. In 2022 the bridge simulator was upgraded with kind donations by member-companies Drylog, Gaslog and Hellenic Mutual War Risks Association.

HS1 BRIDGE RESOURCE MANAGEMENT (5 days)

Based on the IMO Model Course 1.22 and approved by the Cyprus Maritime Authority, consists of 19 topics developed in a total of 40 hours (20 hours of presentations and 20 hours of practical training).

HS2 ADVANCED SHIP HANDLING & NAVIGATIONAL SAFETY (3 days)

7 hours of presentations and 14 hours of practical training.

HS3 NAVIGATING IN DENSE TRAFFIC - FISHING AREAS - COLREGS & LOSS PREVENTION (2 days)

6 hours of presentations and 8 hours of practical training.

HS4 REAL INCIDENT SIMULATION & ROOT CAUSE ANALYSIS (2 days)

Present, simulate and analyse real maritime incidents of members and others from official sources such as MAIB, CHIRP, MARS etc.

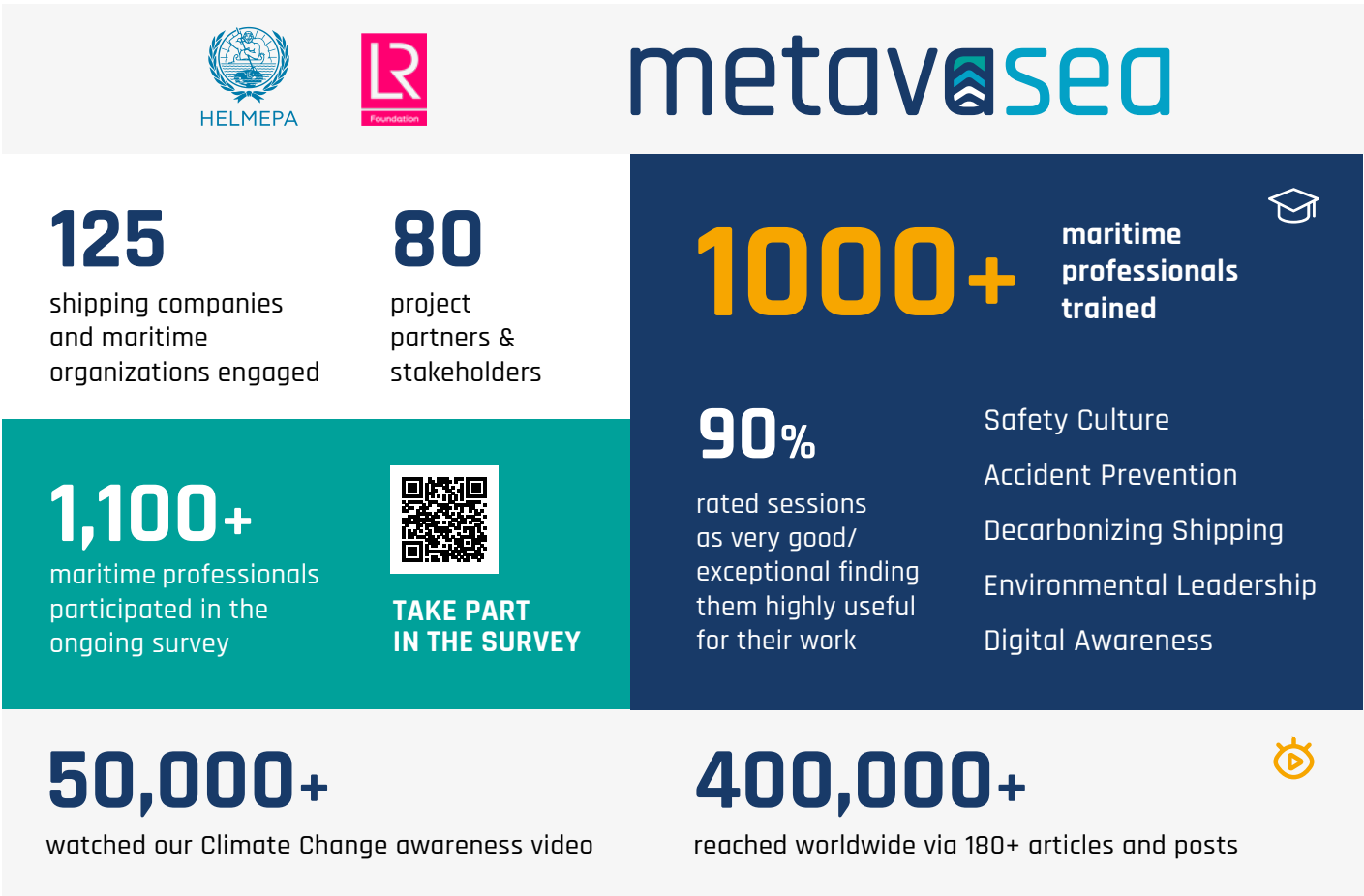


A COLLECTIVE INITIATIVE FOR MARITIME DECARBONIZATION

HELMEPA's flagship initiative METAVASEA continued to expand its reach and impact, delivering over 20 key outputs, including research methodologies, focus groups, surveys, webinars, workshops, seminars, and a wide range of promotional materials.

To amplify its effectiveness, METAVASEA established collaborative frameworks with leading initiatives such as the Maritime Just Transition Task Force, LR Maritime Decarbonization Hub, and REMPEC's Mediterranean Strategy for the Prevention of Pollution from Ships, reinforcing synergies across the maritime sustainability landscape.

117 shipping companies and maritime organizations actively engaged in project activities, contributing valuable insights and strengthening awareness of the initiative's goals



A major milestone was the launch of the METAVASEA Survey, designed to capture perspectives from five stakeholder groups: shipping companies, seafarers, port administrators, civil society, and suppliers.

In-person and online training activities further enriched the program. Notably, 90+ port workers and shipping company employees participated in the seminar “Enhanced Safety Culture for Maritime Decarbonization” at the Piraeus Port Authority, while 583 seafarers and executives attended webinars on topics such as emerging technologies, automation, cybersecurity, accident prevention, and decarbonization strategies.

The first Environmental Leadership Masterclass was successfully held at the Athina Training Center, and the Soft Skills Masterclass, developed through a bottom-up approach.

METAVASEA’s visibility was further enhanced through participation in major events, online publications, and social media campaigns. A dedicated climate awareness video attracted significant attention across digital and television platforms.

At Posidonia 2024, associate partner WISTA Hellas hosted the seminar “A People-Centered Decarbonization Concept Beyond Sea Barriers”, featuring women panelists from diverse maritime sectors and highlighting the gender perspective in decarbonization efforts.

HELMEPA MEETS USCG LEADERSHIP

On March 5 & 6, HELMEPA led its largest-ever member delegation to Washington D.C., headed by Chairperson Semiramis Paliou, to strengthen cooperation with the U.S. Coast Guard (USCG), NAMEPA, and other key stakeholders. The delegation of 24 executives from 20 member companies engaged in high-level discussions on PSC inspections, ballast water and biofouling, the VIDA Act, cybersecurity, emerging technologies, and alternative fuels.

The visit also included participation in the 1st Foresight Maritime Dialogue at Georgetown University and a joint legal-focused event with NAMEPA at Blank Rome, reinforcing the strong HELMEPA–NAMEPA relationship within the INTERMEPA framework.

STRENGTHENING TIES WITH CYPRUS

On September 19, 2024, HELMEPA welcomed Ms. Marina Hadjimanolis, Deputy Minister of Shipping of Cyprus, to its offices, reaffirming the long-standing cooperation between Greece and Cyprus in marine environmental protection and sustainable shipping.

During her visit, the Deputy Minister was briefed on HELMEPA’s work in environmental awareness, safety, and sustainability, as well

as on the progress of the METAVASEA project, which includes participating organizations from Greece, Cyprus, and the Eastern Mediterranean, focusing on the decarbonization of shipping.

Ms. Hadjimanolis also toured HELMEPA’s Bridge Simulator, engaging with merchant marine officers and experiencing firsthand the Association’s training capabilities.



IMO MEPC81

HELMEPA continues to actively contribute to international maritime policymaking through its role as Technical Advisor to the Greek Delegation at the International Maritime Organization (IMO).

From 18–22 March 2024, HELMEPA participated virtually in the 81st session of the Marine Environment Protection Committee (MEPC81), supporting discussions on key regulatory developments related to marine environmental protection.

GREEN AWARD BOARD OF EXPERTS

In May 2024, HELMEPA reaffirmed its commitment to international sustainability initiatives by participating in the Board of Experts meeting of supporting member Green Award, held in Rotterdam.

LRF BOARD OF TRUSTEES

In March, HELMEPA had the honor of celebrating 17 years of collaboration with Lloyd's Register Foundation by presenting to its Board of Trustees the cumulative impact of three LRF-funded initiatives implemented in Greece.

The occasion also marked the opportunity to share the ongoing progress of our most recent joint endeavor: project METAVASEA. This warm and engaging event was kindly hosted by the Athina Maritime Learning Centre, an associate member of the METAVASEA network.



CELEBRATING 18 YEARS OF GLOBAL COLLABORATIONS

In June 2024, the INTERMEPA Steering Committee convened at HELMEPA’s offices to celebrate the 18th anniversary of the Association’s founding. This milestone marks nearly two decades of international cooperation, knowledge sharing, and collective action in support of marine environmental protection.



EMPOWERING MERCHANT MARINE ACADEMIES



Following an invitation by the Ministry of Maritime Affairs and Insular Policy and in close cooperation with Eugenides Foundation, HELMEPA's scientific editorial team compiled the "Marine Environment Protection" publication specially designed for cadets of the Merchant Marine Academies (AEN).

The book has been officially incorporated into their curriculum and is taught during the sixth semester of their academic studies.

Presentations held at the Merchant Marine Academy of Hydra and the Isalos.net event "Epilego Naftilia" led to the registration of 60 new Cadet Members from regional academies, reflecting growing interest in HELMEPA's mission and programs.


Ongoing discussions with additional academies are underway to organize future educational visits, aiming to further engage cadets in environmental awareness, safety culture, and sustainable shipping practices.

VOLUNTARY INCIDENT REPORTING PLATFORM

HELMEPA's VIRP continued to grow, featuring over 1,750 anonymous incident and near-miss reports submitted by 36 managing companies.


These reports have led to valuable "lessons learned" shared across HELMEPA's community through the wide distribution of VIRP Digests compiled by member-companies Tsakos Shipping & Trading SA and DYNAMARINE highlighting the importance of addressing the bank effect and taking all necessary safety measures during STS operations.

Launched in 2021 with financial support from Lloyd's Register Foundation (LRF), VIRP continues to play a crucial role in promoting safety and accident prevention in the maritime industry.

Sharing lessons learned

VIRP Digest is a quarterly e-bulletin, sharing 'lessons learned' from maritime accidents, incidents, and near-misses uploaded by HELMEPA member-vessels to the Voluntary Incident Reporting Platform (VIRP).

Collective impact

1,600+ Reports uploaded to VIRP by 40 member-managing companies that are logged on. Recent upgrade of the VIRP provides users with a wide range of new capabilities and statistical research, enabling smoother user interface and better detection of emerging trends.

Being part of safety culture

All managing company-members of HELMEPA are provided, upon request, with an exclusive access code to upload their vessels' incidents and near misses and view all the database reports and emerging trends through a wide variety of filters.


Enriching provisions and sustainability

Sharing 'lessons learned' from the analysis of previous incidents helps avoid the human errors that lead to the repetition of similar incidents and accidents in the future. Active participation of a company in the VIRP reinforces a strong maritime safety culture at all company levels.


Enhancing Safety during Ship-to-Ship (STS) operations

This article highlights pivotal safety concerns that were highlighted in incidents during STS operations uploaded to HELMEPA's Voluntary Incident Reporting Platform (VIRP) by supporting member Dynamarine.



Voluntary Incident Reporting Platform



ROOT CAUSE ANALYSIS

ROOT CAUSES

- There was a lack of situational awareness by the Mooring Master combined with a misjudgment of weather conditions.
- Inadequate communication amongst involved personnel.

IMMEDIATE CAUSES

- Lack of experience of deck crew personnel during the unmooring stage.
- Mooring Master's poor decision-making actions during the unmooring stage.

IMMEDIATE CORRECTIVE ACTIONS

- The vessel's crew retrieved the mooring lines from the water using winches and a crane.
- Main engine was stopped to prevent propeller damage from tangled mooring lines while the vessel remained safely adrift.
- Master coordinated with the Mooring Master to return the mooring lines to the tugboat for delivery to the other vessel.
- Mooring Master informed nearby vessels about the vessel's limited maneuverability situation.
- The incident investigation report was later distributed across the fleet and discussed in detail among all officers and crew to ensure comprehensive understanding and application of the lessons learned.


LESSONS LEARNED

The assessment of Safety, Quality and Reliability of the nominated Service Provider is paramount and it is a due diligence obligation of the technical operator as user of their services.

To avoid communication failures, during the toolbox meeting both Masters and the POAC should have a clear understanding of what actions should be followed at each stage of the STS operation (i.e. mooring/unmooring sequence, cast off criteria etc.).

The company should provide the vessel with toggle pins to take the load of the mooring line while it is removed from the mooring bitts.

Deck Officers should undertake training with respect to assessment of mooring plans, mooring and unmooring processes including the use of toggle pins.

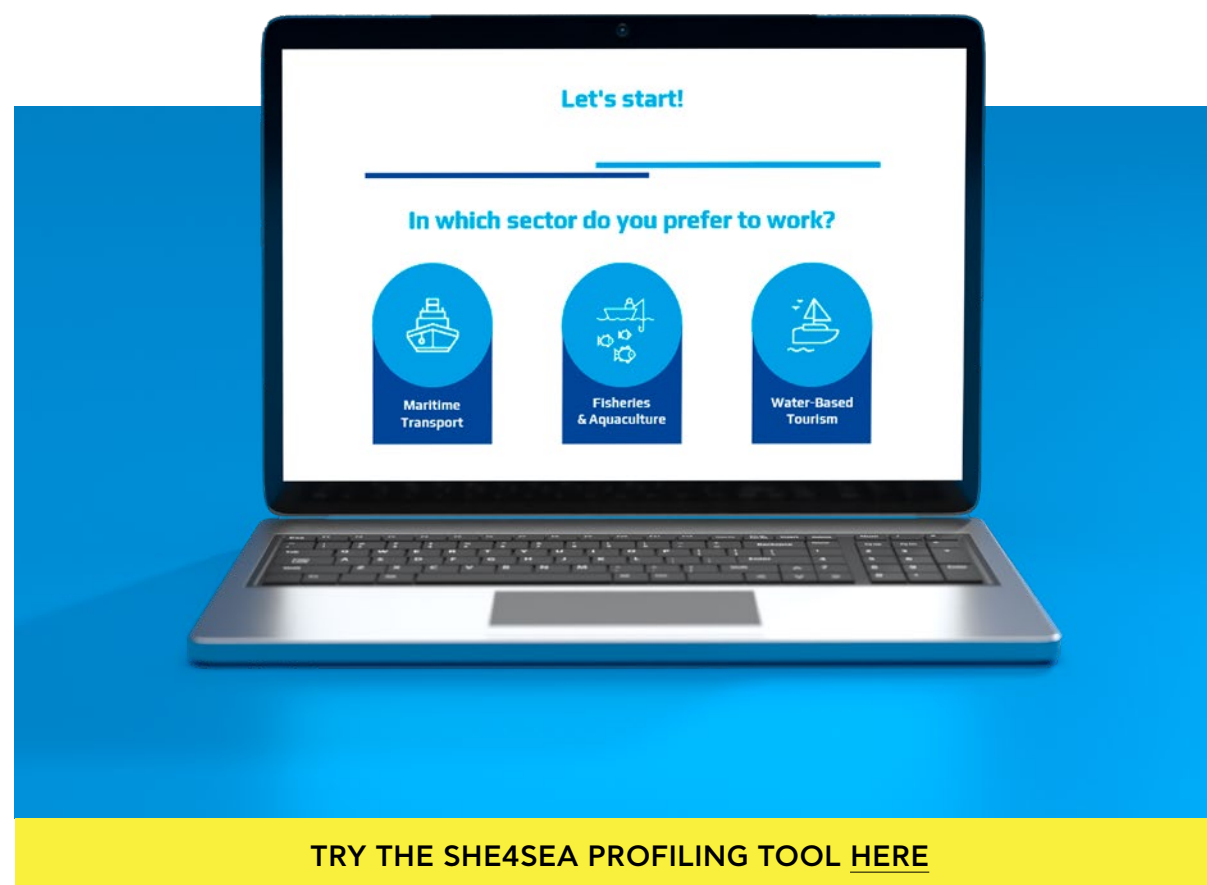
EMPOWERING WOMEN IN THE BLUE ECONOMY

In its second year, the She4Sea Erasmus+ program delivered solid results, advancing gender inclusion in maritime professions.

The She4Sea Competence Framework and Compendium are now available in four languages—English, Greek, Spanish, and Bulgarian—supporting the development of inclusive training materials.

The She4Sea digital Profiling Tool continued to grow, helping primarily unemployed women assess their strengths, reflect on their professional experiences, and engage in targeted training activities. These tools offer practical guidance, learning opportunities, and personal development pathways, empowering women to pursue careers in the Blue Economy.



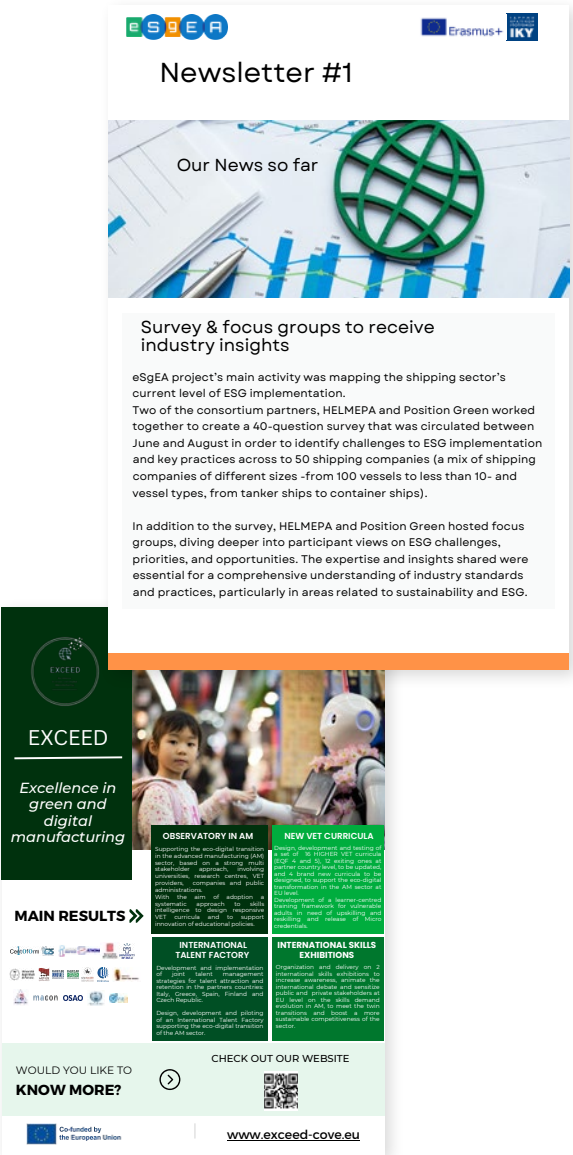
ADVANCED MANUFACTURING IN SHIPPING



In its second year, the EXCEED Erasmus+ project launched the International Observatory on Advanced Manufacturing (AM), analyzing how digital and green transitions are reshaping the sector—impacting technology, employment, and skills demand.

Project partners are co-designing five new Higher VET curricula (EQF 4 & 5), updating twelve existing ones according to the EXCEED Design Principles, and implementing an Upskilling Training Programme for VET professionals, promoting gender-sensitive, inclusive, and internationalized education.

Among the contributors, HELMEPA is developing a new curriculum on shipping decarbonization, supporting the Greek Center of Vocational Excellence (COVE) and advancing sustainability in maritime education.



ADVANCING ESG IN SHIPPING



In 2024, the eSgEA Erasmus+ project completed its first-year activities, laying the groundwork for ESG integration in the maritime sector.

The project developed a methodology for assessing ESG implementation and conducted focus group consultations in Greece and Norway, identifying key challenges and opportunities.

These initial steps pave the way for the development of an interactive training program, aimed at supporting shipping professionals in adopting ESG practices and fostering a culture of sustainability across the industry.

POSIDONIA 2024

HELMEPA's impactful presence at Posidonia 2024 was a resounding success, resonating both on shore and at sea. Centered around the theme "Shipping Resilience to Climate Change," the conference convened over 500 maritime leaders on World Environment Day to address pressing environmental challenges and advocate for sustainable practices. This landmark event underscored the urgent need for the shipping industry to address climate change, emphasizing its commitment to environmental protection and sustainable development.

The conference echoed the message that "In unity, there is strength," engaging participants in high-level discussions on achieving IMO targets, implementing operational and technological measures, enhancing data sharing, and promoting timely decision-making.

OCEAN AWARE THRU ARTIVISM

HELMEPA organized a Group Visual Arts Exhibition in the heart of Athens, at the Stelios Philanthropic Foundation Conference Hall in Plaka, showcasing 1,000 artworks created by students aged 5 to 18

Inspired by the sea, students shared their own messages of hope and action for ocean protection through their creative work. The exhibition remained open for two weeks, welcoming 400 students and 50 teachers from both primary and secondary education.

Visitors had the opportunity to attend presentations on the importance of the oceans, marine pollution, climate change, and the UN Sustainable Development Goals (SDGs), enriching their understanding of environmental challenges and solutions.

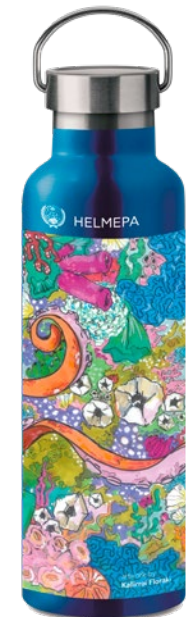


HELMEPA YOUTH AMBASSADORS

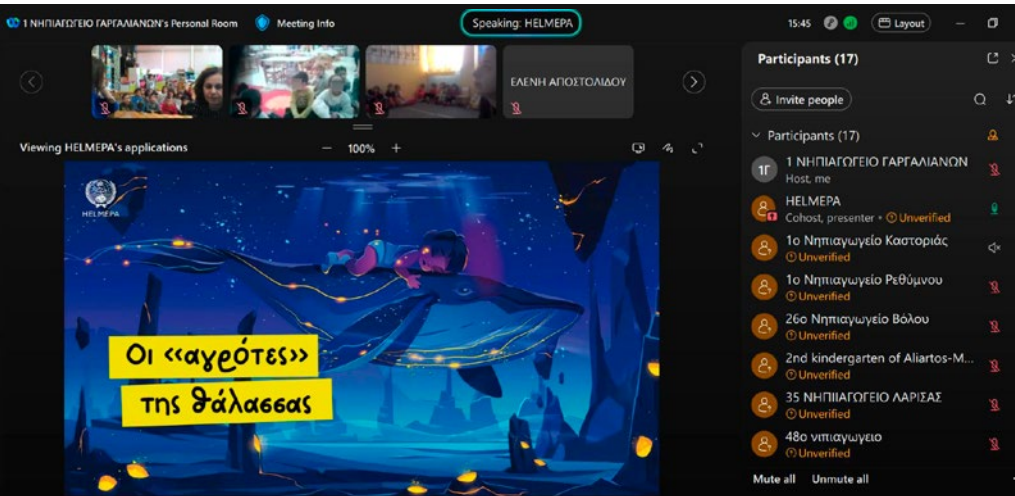

BRINGING THE SEA INTO THE CLASSROOM

Throughout the year, HELMEPA leveraged digital tools to deliver online presentations focused on the protection of the marine environment from pollution.



As part of the “Us and the World” program by Hellenic Hull Management, HELMEPA virtually visited 29 remote elementary schools, engaging 630 students in meaningful discussions about marine conservation.

These remote sessions proved to be particularly impactful, enhancing the dissemination of environmental knowledge and reaching schools that would otherwise be difficult to access.



WE RUN TO SAVE THE SEAS

HELMEPA actively participated in the Spetses Mini Marathon, the largest multi-sport event in the country.

HELMEPA Board Members Michail Dalacouras and Maria Hajioannou, General Director Olga Stavropoulou, adult volunteers, and Youth Ambassadors actively participated in the activities, sending strong messages in support of marine environmental protection.

For the first time in the history of the Spetses Mini Marathon, HELMEPA Youth Ambassadors collected the plastic bottles used by athletes, compressing them, and placing them in blue recycling bins, ensuring proper recycling and waste management.

This simple yet impactful initiative brought environmental awareness to the forefront of the event, highlighting the importance of responsible behavior and youth engagement in sustainability.



LEARNING THROUGH ACTION

MORAITIS SCHOOL

As part of the “A Day Without Lessons” initiative at Moraitis School, HELMEPA delivered an engaging presentation on marine litter and the climate crisis, attended by 140 first-year high school students.

The activity concluded with a voluntary beach cleanup in Artemida, transforming knowledge into hands-on action. Students experienced firsthand the impact of pollution and the importance of collective responsibility, reinforcing environmental awareness through experiential learning.



MORE SCHOOL VISITS

Through engaging sessions on climate change and marine pollution, children explored the challenges facing our seas and learned how they can be part of the solution.

The visit culminated in a symbolic underwater cleanup at the Chios Fish Market, organized in collaboration with volunteer divers from MEPP. More than 90 children and teachers participated in this meaningful action, combining experiential learning with hands-on environmental stewardship.



CAMPION SCHOOL

HELMEPA delivered a dedicated presentation on marine litter to 60 students of Campion School, aiming to raise awareness and inspire active participation in volunteer actions for the protection of the seas.



PSYCHICO COLLEGE

135 second-year high school students from Psychico College, accompanied by 10 teachers, carried out a volunteer beach cleanup at Avlaki Beach in Porto Rafti.



INTERNATIONAL DAY OF ACTION AGAINST PLASTIC POLLUTION

On the occasion of the International Day of Action Against Plastic Pollution, HELMEPA joined forces with Common Seas, the initiative's coordinator, to educate and mobilize children and youth across Greece.

HELMEPA provided educational material, informational videos, and eco-friendly habit tips, while also hosting a live Q&A session, during which students' questions on marine litter were answered in real time.



The campaign reached 10,920 students from 179 schools, delivering a powerful message on the urgency of tackling plastic pollution

ALFEIOS ECO FESTIVAL

HELMEPA's electric van traveled to Pyrgos, participating in the Alfeios Eco Festival, a vibrant celebration of environmental awareness and community engagement. During the event, 150 students from four primary schools, along with members of the local community, were informed about the importance of protecting the marine environment.



NEW SCHOLARSHIPS TO YOUNG SCIENTISTS

Five new scholarships were granted to young scientists for postgraduate studies for the academic year 2024–2025, with a total value of €65,000 honoring the memory of Georgios P. Livanos, Captain Vassilis C. Constantakopoulos, Stavros Daifas, Vasos Chatziioannou, Nikolaos S. Apostolopoulos.

Since 1998, a total of 61 scholarships have been granted with the support of donors and HELMEPA member companies, providing tangible support to young people as they grow, evolve, and pursue their dreams.

COASTAL & UNDERWATER CLEANUPS THROUGHOUT GREECE

In 2024, our collective commitment reached a historic milestone: 316 underwater and coastal cleanups were successfully coordinated, mobilizing 15,405 volunteers from all walks of life

As the national coordinator of the International Coastal Cleanup for 34 consecutive years and the Let's Clean Up Europe campaign for 11 years, HELMEPA continues to lead impactful, large-scale marine conservation actions across Greece.

These actions resulted in the cleaning of 77.5 kilometers of coastline and the removal of 27.5 tons of marine litter, reaffirming our mission to protect Greece's marine and coastal ecosystems. The active engagement of 397 stakeholders including schools, municipalities, companies, and civil society organizations demonstrates the power of collaboration and shared responsibility.

MAKE EU BLUE CAMPAIGN

In September 2024, HELMEPA proudly participated in the MakeEUBlue Campaign, reaffirming its role as an active member of the EU4Ocean Coalition. As part of this pan-European initiative to promote ocean literacy and environmental stewardship, HELMEPA coordinated a symbolic cleanup action at Edem and Batis beaches, welcoming the enthusiastic participation of international students.



MEGA JOINT BEACH CLEANUP

HELMEPA organized one of the largest coastal and underwater cleanup actions to date, in front of the Peace and Friendship Stadium, mobilizing 440 volunteers from 33 member companies. With technical support provided by Antipollution, the team successfully removed 420 kg of marine litter, reaffirming our shared commitment to protecting the marine environment.

Beyond the cleanup, this initiative embraced HELMEPA's broader mission of environmental education. Participating member companies donated sea-themed books, which were distributed to school libraries across Greece in collaboration with Library4all, inspiring young minds and cultivating ocean awareness from an early age.

MARINE LITTER MONITORING



COMMITMENT TO SCIENCE AND IMPACT

In its inaugural year, HELMEPA’s Marine Litter Monitoring (MLM) Program sparked remarkable interest, achieving 13 coastal adoptions across Greece. This impactful yet straightforward initiative invites organizations to commit to a three-year beach adoption, conducting seasonal marine litter surveys at least twice, ideally four times per year, at a designated site.

The program’s data directly supports the international scientific community, offering actionable insights and driving tangible solutions to global marine pollution challenges.

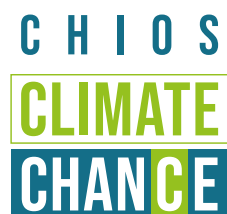
HELMEPA's dataset was integral to the final report, released in December 2024 in both Greek and English, showcasing key findings and offering actionable recommendations to combat marine litter.

Chios Climate Chance (CCC) is a pioneering model of social innovation, implemented for the first time in Greece by HELMEPA, with co-funding from the Maria Tsakos Public Benefit Foundation and the John S. Latsis Public Benefit Foundation.

This human-centered initiative empowers the residents of Chios to understand climate change, recognize their role in the solution, and adopt sustainable practices for a better future.

Designed with a flexible and adaptive methodology, CCC responds to local characteristics, creating a movement of positive engagement with measurable results. From the very beginning, the people of Chios embraced the program:

The official launch was marked by the Climate Conference in Chios, with 365 participants, including scientists, government officials, and business leaders. CCC built a multi-stakeholder network of 19 local supporters, including the Municipality of Chios and the Directorate of Primary Education, amplifying the campaign's reach.

Key actions included:

- Visits to 6 schools
- Presentations at 5 associations and clubs
- 7 beach cleanups and 1 underwater cleanup
- Climate-themed interventions at summer cinemas

A cornerstone of the campaign is the Climate Ambassadors Digital Toolkit, an open-access resource designed to empower every individual. This comprehensive platform offers reliable data, short educational videos, visual materials, practical guidance, and activity templates, equipping citizens with the tools to transform awareness into meaningful action.

Upon completion, participants receive a Climate Ambassador Certificate, recognizing their commitment to environmental stewardship.

The CCC was officially integrated into the pan-European framework of actions supporting Agenda 2030 and the UN Sustainable Development Goals (SDGs), as part of the European Sustainable Development Week 2024.



EMPOWERING YOUTH IN PURSUING A CAREER IN THE BLUE ECONOMY

The Big Blue Accelerator, implemented by HELMEPA in partnership with Knowl S.E. and supported by The Hellenic Initiative, is a youth skills program for maritime professions. It targeted motivated young people aged 18–25 from the Dodecanese and other remote Greek islands, offering them access to career development opportunities.

Over 700 hours of training, mentoring, and mock interviews were delivered by 35 trainers and mentors from HELMEPA's and Knowl's networks. 23 participants from Chios, Kalymnos, Karpathos, Kasos, Kos, Rhodes, Samos, Symi, and Tilos developed their strengths, built essential soft and digital skills, and gained direct connections with the Blue Economy job market.

Running from January to October 2024, the initiative culminated in a graduation ceremony at the Stelios Philanthropic Foundation Hall in Athens, celebrating the achievements and transformative journeys of the participants.

OCEAN & CLIMATE LITERACY IN NAUTICAL HIGH SCHOOLS



HELMEPA participated in the Nauticinblu Europe program, an international initiative promoting ocean and climate literacy among students in nautical high schools. The program, coordinated by the Italian NGO Marevivo and supported by the MSC Foundation, involves Nautical Institutes in Italy, Greece, Portugal, and Spain. In Greece, HELMEPA is the implementing partner.

A total of 130 students from the 1st Vocational High School of Keratsini, Attica, and the Tsakos Enhanced Education Nautical School (TEENS) in Chios took part in a 10-day Ocean Literacy training program. The curriculum included in-class seminars, experiential workshops, and outdoor activities such as beach cleanups and ocean-themed art projects. Students explored key topics including ocean and climate awareness, the blue economy, sustainable economic growth, biodiversity, and the role of the oceans in climate regulation.







In April 2024, HELMEPA played a pivotal role in the 9th Our Ocean Conference, held in Greece, by organizing a series of high-impact, youth-centered events under the BLUE HORIZONS initiative. These activities were carried out in close collaboration with the Greek Government, the U.S. Department of State, the Sustainable Ocean Alliance, and our strategic partner, the Yacht Club of Greece (YCG).

The program commenced with a Youth Mega Beach and Underwater Cleanup at the Peace and Friendship Stadium coastline, mobilizing over 500 volunteers aged 5–35. The cleanup was technically supported by Antipollution and the Mediterranean Company Environmental Protection (MEPP).



Later that day, HELMEPA and the Yacht Club of Greece (YCG) co-hosted an inspiring Cultural Youth Reception, welcoming over 100 youth delegates from 43 countries. Held at the historic premises of YCG, the event featured a keynote address by Mr. George Procopiou, who encouraged young participants to explore career paths within the Blue Economy. This reception served as the official cultural component of the 9th Our Ocean Conference, celebrating Greek hospitality, youth leadership, and the shared commitment to a sustainable maritime future.

On the day following the Youth Mega Cleanup, HELMEPA and the Yacht Club of Greece (YCG) co-organized the official Youth Leadership Summit at the Stavros Niarchos Foundation Cultural Center (SNFCC). The Summit placed a strong emphasis on sustainable oceans and the Blue Economy, featuring keynote addresses by HELMEPA Chairperson Ms. Semiramis Paliou, Minister of Environment Mr. Thodoros Skylakakis, and other distinguished speakers from the maritime and environmental sectors.

The program included a Design Thinking Lab and an on-the-spot mentoring session, led by prominent experts from HELMEPA’s Board of Directors and membership community. These interactive sessions provided youth delegates with personalized guidance, career insights, and practical knowledge on sustainable maritime professions and innovation.

On the final day, HELMEPA hosted a dedicated event on Women in the Blue Economy, spotlighting the critical role of women in shaping the future of ocean sustainability.

YOUTH VISITS

In April 2024, HELMEPA welcomed students from TEENS – Tsakos Enhanced Education Nautical School to its Bridge Simulator in Athens. The visit featured an interactive session on the 17 UN Sustainable Development Goals (SDGs), connecting maritime education with global sustainability efforts and fostering environmental literacy among the next generation of seafarers.

In parallel, HELMEPA hosted students from the University of the Aegean's MSc in Shipping, Trade and Transport for an edutainment day at its headquarters. The program included presentations and a hands-on session at the Bridge Simulator, offering participants practical insights into maritime operations, safety culture, and sustainability in shipping.



UNION FOR THE MEDITERRANEAN STAKEHOLDER CONFERENCE ON SUSTAINABLE BLUE ECONOMY

HELMEPA actively participated in the 2nd Union for the Mediterranean Stakeholder Conference on Sustainable Blue Economy, held in Athens, in February and hosted by the Greek Ministry of Maritime Affairs and Island Policy, in collaboration with the UfM EU and Jordan Co-Presidency and the UfM Secretariat.

INITIATIVES IN HYDRA & ANDROS

Following the success of the Blue Life Kavala initiative, HELMEPA expanded its outreach with two new impactful actions in Hydra and Andros, placing youth participation and community engagement at the heart of the effort.

In Hydra (March 21), HELMEPA delivered presentations in primary and secondary schools, engaging over 150 students, as well as at the Hydra Merchant Marine Academy, with more than 60 participants. A local stakeholder forum was also held, featuring 28 representatives, including HELMEPA Board Member Maria Hajioannou.

The forum was moderated by HELMEPA's General Director, Olga Stavropoulou, and was complemented by an underwater cleanup in the port of Hydra.

The forum welcomed distinguished guests such as:

- Olga Kefalogianni, Minister of Tourism (via video)

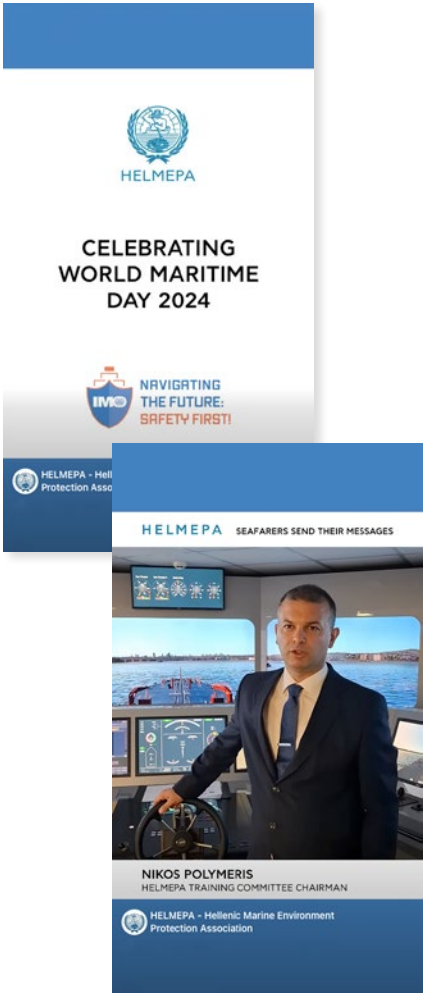
WORLD MARITIME DAY 2024
